- 1. Call Meeting of the Board of Adjustment to Order by Leddy at 4:04 pm.

- 4. Approval of Agenda by Johnson second by Mach carries 7-0.
 - Approval of Minutes: January 13, 2020 motion by Hansen second by Pillatzki carries 7-0.
- 5. Disclosure of Conflicts/ Ex Parte Communication- Leddy recuses from the Chair for relationship of family and Johnson resides over the CUP. McCulloch is seated in Leddy's recusal.
- 6. Matters for Board discussion/ staff report
 - a. Conditional Use Permit Application request from John and Annelies Seffrood on the following legal description: S ½ of Section 10-121-52

A Conditional Use Permit, CAFO03092020, Pursuant to Section 1101.03.10: Conditional Uses in the "A" Agricultural Zoning District #10 - Class A Concentrated Animal Feeding Operations. The applicants, John and Annelies Seffrood, are requesting a conditional use permit to expand an existing dairy facility to house up to a maximum of 6,200 mature dairy cattle (Class A CAFO).

A motion is made by Pillatzki and second by Spartz. Discussion opens at 4:30 pm with Kays presenting the staff report. Johnson begins the Permit presentation by calling the applicant for 10 minutes of time. Annalies begins the discussion by presenting the facts of their 22 year history at the site and the need to expand going forward. She points out the area can handle the crop need increase and the manure use area available. She turns the discussion over to Paul Kostboth, A1 Engineering who presents the Easterly move allows preservation of good site with good neighbors and a good position for long term. Evan Grong presented the support from Valley Queen by reading a letter from Jason Mischel.

Johnson opened the public hearing. Kays asked the audience if there was anyone who wished to speak that had not been asked prior. Bill Tostenson, Commissioner, stated he had been on site and toured the facility and pledges his support. Dr Sousa gives his support to the expansion. Johnson called 3 more times for those in favor or opposed to speak and no one appeared or interjected so Johnson closed the public portion of the hearing.

Questions from the board were fielded to clarify storage space for feed and the increase with access, core samples for DENR and process, water usage for the future will continue to be well with 2 rural waters having been notified, roof runoff currently into capture and to lagoons when contaminated,

feed storage and polluted water is already in containment and storm water that is not contaminated is taken to the back of the farm to release, existing land use around the dairy is mostly crop with some pasture. With no further questions Kays reads the Findings of Fact for the approval of the board with no one dissenting any items as read and no additional conditions placed upon the permit. A roll call was taken with unanimous approval by seated board.

With the permit completed and vote noted Johnson relinquishes Chair position to Leddy for the remainder of the meeting. McCulloch returns to alternate position.

- 8. Address to the Board of Adjustment- Leddy again asks if anyone wished to address the board.
