Sheriff's fees for the month of November were \$11,183.46 with \$4,476.46 receipted into the County's General Fund. The Register of Deeds fees for the month of November were \$6,885.75. The Clerk of Courts fees for the month of November were \$10,644.74.

Drainage: Chairman Mach adjourned the Board of Commissioners and convened the commission acting as the Drainage Board. The Drainage Administrator was present.

Buri/Bury/Kohl Drainage: Landowner Dennis Kohl reported the elevation levels have not been done yet, so there is not any changes to report. Chairman Mach stated the Commission will consider the matter closed unless an amendment or a new permit is needed.

Drainage Officer Krista reported she had been contacted by the NRCS about unpermitted drainage showing up on the google earth maps. She asked if the landowners should be contacted to fill out a drainage application. She will research the parcels involved and report back to the Drainage Board.

This concluded the business for the Drainage Board. Chairman Mach adjourned the Drainage Board and reconvened the Board of Commissioners.

Highway: Landowner Charlie Russman discussed the flooding of his residence when large rains occur. He requested a culvert be placed diagonal from the SW corner of his driveway to the NE across the county road by his residence to channel the water to go north. Discussion was held how the installation of the proposed culvert would alter the flow of water to the north instead of going into the natural run which is the creek. Also, discussed was the need to clean out the creek of fallen trees and branches as these are restricting the water flow in the creek. Commissioner Stengel will look at the site. <u>BIG Grant:</u> Supt Schultz presented the documents to send to DOT for the next round of the Bridge Improvement Grant (BIG) selection process. The application is for the bridge located .5 miles south of Revillo. The application is for a cost share of 80/20 and construction date would be 2019 if the county is awarded the grant. Motion by Stengel and seconded by Buttke for Chairman Mach to sign the resolution authorizing the submission of the application for structure 26-325-222, the ROW Certificate and the Utilities Certificate. Project number is BRF 6311(00). Motion carried 5-0. The projected cost of the bridge is \$430,000.

<u>Preservation Grant:</u> Also presented for approval were three resolutions to submit for preservation grants on bridges in Big Stone Township. The three bridge numbers are 26-309-029 located .5 miles south and 6.5 miles west of Big Stone City on County Road 4, the second one is 26-352-030 located .5 miles south and 2.4 miles west of Big Stone City on County Road 4 and the third on is 26-360-032 located 1.0 miles south and 1.5 miles west of Big Stone City on County Road 39. If the grants are awarded the County would have 3 years to complete the project. Motion by Buttke and seconded by Stengel to authorize Chairman Mach to sign the grant application resolutions. Motion carried 5-0. The projected cost of the three bridges is \$1,316,620.

<u>Change Order:</u> Motion by Dummann and seconded by Street to approve Change Order Number 1 for project BRF 6311 (00) PCN 01DR for two box culvert replacements by Albee for an increase in the construction cost of \$940.70 due to additional rip-rap. Motion carried 5-0.

A discussion was held on managing county funds if all the grants were to be awarded as the 2019 budget would have a shortfall of cash. The rules have changed on the BIG funding and it is now a reimbursement process for grant projects.

Lake Albert: Auditor Layher reported she had contacted the Water Rights division of DENR in Pierre. The Game Fish and Parks holds the water right for Lake Albert and the County would need to contact the office in Webster for any work that needs to be done in relation to the maintenance of the outlet channel. The GF& P supervisor from Webster had been onsite and sent pictures of the outlet channel and reported the water is flowing out of the outlet and attributes the high water level due to the amount of rains received last fall. The County installed the culvert outlet in 1994. Present for the discussion were Robert Hinders, Jr and Jim DeWald Big Stone Twp Supervisor. Both individuals had been on site at the outlet and indicated the run should be cleaned to keep the water moving. Auditor Layher will contact GF & P in Webster to discuss the cleaning of the outlet and process to follow. Commissioner Stengel stated he will look at the outlet.

P & Z: Commissioner Street introduce Derek Nelson who is interested in a position on the P & Z Board. Commissioner Stengel brought forth the name of Jeff McCulloch for the alternate appointment. The Commission held a discussion on the candidates for the appointment to the alternate position on the P & Z board. Motion by Dummann and seconded by Buttke to appoint Jeff McCulloch for the open alternate position. Motion carried 5-0. Chairman Mach brought forth for consideration to pay the alternates each month as they need to review the materials before each meeting as the board member do in case they are needed to replace a board member who is absent. Motion by Stengel and seconded by Street to have the alternates in attendance at each P& Z meeting in order to be kept current on actions of each meeting and to be paid the board fee of \$125 for each meeting attended. Motion carried 5-0.

<u>Campaign Finance</u>: As per the Commissioner's request a resolution was presented for campaign financing laws to be applicable to county elections as in the past. Recently the law was changed to apply to counties over 10,000 in population with the option for each local entity to adopt a resolution or an ordinance to apply the laws. Motion by Dummann and seconded by Stengel to adopt the following resolution to be effective with the 2018 elections. Motion carried 5-0. Resolution adopted.

RESOLUTION NO 2017-37

RESPECTING APPLICATION OF CAMPAIGN FINANCE REQUIREMENTS IN GRANT COUNTY, SOUTH DAKOTA

A RESOLUTION to make the provisions of SDCL 12-27 et. seq. regarding campaign finance requirements applicable to elections in Grant County, South Dakota.

WHEREAS the provisions Chapter 12-27 et. seq. apply to each statewide office, legislative office, statewide ballot question, county offices and ballot questions in counties with populations greater than ten thousand according to the most recent Federal census, and ballot questions in first class municipalities, and school district offices and ballot questions in school districts with more than two thousand average daily membership; and

WHEREAS SDCL 12-27-39 allows the governing body of any county with populations less that than the above stated populations to adopt by ordinance or resolution the option to make the provisions of SDCL 12-27 et. seq. applicable and required by such county; and

WHEREAS, the Commissioners of Grant County, South Dakota deem it desirable to conform to the campaign finance requirements set forth in SDCL 12-27 et. seq., with or without amendments.

BE IT RESOLVED, by the Grant County Commissioners, Grant County, South Dakota that the campaign finance requirements as set forth in SDCL 12-27 et. seq. shall be applicable to county elections.
