October 18, 2022

The Grant County Commission met at 8:00 AM with Commissioners Buttke, Mach, Stengel, Street and Tostenson. Chairman Stengel called the meeting to order with a quorum present. Motion by Street and seconded by Buttke to approve the minutes of the October 4, 2022 meeting as presented. Motion carried 5-0. Minutes filed. Motion by Mach and seconded by Buttke to approve the agenda with item number four, the first reading of 1997-1E removed as it was a double entry. Motion carried 5-0.

Member of the public present: Milt Stengel. Staff member present was States Attorney Schwandt.

The Auditor's Account with the Treasurer for September was noted.

The Register of Deeds fees for the month of September were \$14,674.00, the Clerk of Courts fees for the month of September were \$6,510.84. The Sheriff fees for the month of September were \$27,958.13 with \$1,958.13 receipted into the General Fund.

<u>Public Comment:</u> Chairman Stengel called for public comment. There were no comments. Chairman Stengel closed the public comment.

<u>Drainage:</u> Chairman Stengel adjourned the Board of Commissioners and convened the Commission acting as the Drainage Board.

Permit DR2022-61 for Milton Stengel for property owned by E & M Farms, Inc., and located in NE1/4 EX RTY in 28-121-48(Melrose Township). Motion by Tostenson and seconded by Street to approve DR2022-61. Chairman Stengel asked Berkner to present his report.

Drainage Officer Berkner stated the tiling project will impact between 40 to 50 acres of land located in parts of Section 28 in Melrose Township. The project may have one outlet that would drain southeast directly into an established waterway. The 10" outlet could drain as much as 340 GPM if it ran full at a .1% grade. The tile permit presented showed no inlets in the project. Berkner closed his report saying the six questions under section 101 were answered in the affirmative and the other list of questions in Section 313 and 317 support the affirmative response.

Chairman Stengel asked Milt Stengel for any additional information. Milt stated this project would take care of some troubled spots where in wet years he was unable to farm very successfully.

Chairman Stengel opened the public hearing asking three times for any comments in support of or against permit DR2022-61 with no one responding. Chairman Stengel then closed the public hearing and asked the Board to begin discussion.

Commissioner Tostenson stated he had personally inspected the project saying it was a straightforward project. He asked if there would be any inlets. Milt Stengel responded that there may be a need for one on the west side of the project area where water tends to pond. He stated that when the project begins, it would be determined if the inlet is needed. Commissioner Tostenson asked if Milt would consider using a "whisk inlet drain," like ones being installed through another permit recently approved. Milt replied he would research the whisk inlet. County Auditor Layher said she would email information on the "whisk inlet."

Commissioner Street asked if any of the downstream neighbors might be concerned about the project. Milt Stengel responded he had spoken to the adjoining landowners, and no one voiced any concerns. Berkner added that he had one phone call from a downstream neighbor who received a certified letter who said they had no problem with the project as it was described to them.

With no more discussion, Chairman Stengel asked for clarification if he should cast a vote for this tiling project that involves his cousin. States Attorney Schwandt replied if Milt Stengel wasn't a direct family relation, and that he did not receive any financial interest from the project, he could vote. Chairman Stengel answered that he had no ties with the land being tiled. Chairman Stengel called for the vote on DR2022-61. Motion carried 5-0.

This concluded the business for the Drainage Board. Chairman Stengel adjourned the Drainage Board and reconvened as the Board of Commissioners.

<u>Cash Transfer:</u> Motion by Street and seconded by Buttke to approve the cash transfer from General Fund as per the 2022 budget. Motion carried 5-0.

<u>Drainage Fee:</u> States Attorney Schwandt reported he had reviewed the statutes regarding implementing an administration fee in addition to the permit fee of \$100 that is set by statute. He advised the Commission he could not find any statute that

would allow the application of an administration fee. Any change in the permit fee would require legislative action.

Highway: Present were Hwy Supt Schultz, Assistant Supt Daren Peterson and Paul Kosbath who addressed the Commission on a ROW occupancy request by Lakeside Biogas. The occupancy of the pipe is located on 149th St., 452nd Ave., and 146th St. in Sections 29, 28, 27, 22, 15 and 10 in Township 121, Range 52. He explained the partnership of UGI Corporation, Cal Bioenergy and Sevena Bioenergy who have developed clusters of dairy farm digester projects to produce renewable natural gas from methane gas produced by the dairies. The biogas gathering line will go from Blooming Valley Dairy Farm to Lakeside Dairy. From Lakeside Dairy the gas will be hauled to another location and sold to a natural gas company. He indicated that biogas projects reduce waste, increase the use of renewable energy, reduce long term greenhouse gas emissions, and improve the economics for dairy farms. The SD Legislature created legislation that requires any person who operates a biogas gathering line in a public ROW to place and maintain signage for marking the line and listing contact information. The County would not be responsible for installing, maintaining, or relocating the line for any county work needing to be done in the ROW. Supt Schultz stated he had no objection to the ROW request. Motion by Tostenson and seconded by Mach to approve the occupancy application ROW 2022-11 as presented. Motion carried 5-0.

<u>First Responder Class:</u> Motion by Buttke and seconded by Street to approve a payment of \$150 for each first responder who completes the EMR class as per the recommendation of EM Kevin Schuelke. Motion carried 5-0.

P & Z: Chairman Stengel asked Todd Kays with First District of Local Government to provide an overview of the Planning and Zoning Board's work involving the proposed changes to Ordinance 2004-01 as well as an explanation of the proposed changes. Todd noted there were four scripter errors that were corrected through the removal of Lake Park District, changing west to east in Section 292. The Planning and Zoning Board voted at their meeting to recommend to the Commission the changes to the zoning ordinance. The recommended changes include defining ornamental trees used for landscaping, animal and farm fences, privacy fences, walls and hedges, vision clearance on corner lots, extended home occupations and shelterbelt setback requirements. After this was done, Chairman Stengel opened the public hearing and called three times for proponent testimony and for opponent testimony on Ordinance 2022-01A. There was no one

present to offer any public comment. Chairman Stengel closed the public hearing and called for discussion amongst the Commission. Commissioner Street asked if Section 1202 for Vision Clearance on Corner Lots included crop encroachment within the ROW. Todd clarified this section is for structures, fencing or shelterbelts that obstruct the view.

Chairman Stengel called for a motion to hold the first reading by title only. Motion by Mach and seconded by Tostenson to have the first reading of the Ordinance by title only. Motion carried 5-0. Auditor Layher read the titled ordinance.

ORDINANCE NO. 2022-01A

AN ORDINANCE ENTITLED, AN ORDINANCE TO AMEND ARTICLE II "DEFINITIONS", ARTICLE XI "ZONING DISTRICTS", AND ARTICLE XII "GENERAL REQUIREMENTS", ADOPTED BY ORDINANCE 2004-01, AS AMENDED OF THE ZONING ORDINANCE OF GRANT COUNTY

Chairman Stengel called for a motion to set the second reading of the ordinance. Motion by Tostenson and seconded by Mach to set November 1st at 9 AM for the second reading of Ordinance 2022-01A. Motion carried 5-0.

Drainage: At the December 21, 2021 meeting, the Commission had discussed if the cost of a drainage permit could be done by parcel or by project area. Under the current ordinance, the permit fee is defined by project which may be one landowner or several. If the cost of a permit was defined by parcel, the cost of the permit would be for each parcel identified in the project. The Commission had requested the States Attorney to review the drainage ordinance for possible change to reflect the permit fee by parcel. States Attorney Schwandt informed the Commission he had prepared the revision to the drainage ordinance to reflect the change that each parcel of land as identified by the County parcel identification number, must have its own separate drainage permit. He advised the Commission the proposed ordinance change would require a first reading and a second reading with a public hearing. Motion by Tostenson and seconded by Mach to hold the first reading of the proposed ordinance. Motion carried 5-0. Auditor Layher read the title of the ordinance.
