- 1. Call Meeting of the Planning Commission to Order by Chair Johnson at 4:10 pm
- 2. Items to be added to agenda by Board Members or Staff- Johnson asked to discuss policy on conflict of interest with a definition from the State's Attorney during the Board discussion portion of the meeting.

- 6. Plat

Richard, Sandra, Roger & Stephanie Hansen, owners, request the plat of Lot 1, Chris Lewis Subdivision located in S1/2 of Section 26, Township 120 North, Range 50 West of the 5th P.M., Grant County, South Dakota. (Twin Brooks Township)

After presentation by Atyeo-Gortmaker of the plat and representation of such plat being within the guidelines of the Grant County specifications the Planning Commission by a motion from Pillatzki and a second by Spartz unanimously approve the plat.
